The Isle of Man has an advanced telecommunications infrastructure that has frequently been used as a test bed for emerging technologies:

- 5Gbps Multi Protocol Label Switching (MPLS) network, offering high capacity fully managed and flexible connectivity into the UK

Financial incentives

The Island has an innovative and proactive taxation strategy which has strengthened the Island's competitive position internationally and made it highly attractive to e-gaming businesses:

- Low betting duty of between 1.5% and 0.1%, on gross profit
- 0% Corporation Tax; No capital gains tax
- Preferred location for non-UK companies wishing to list on AIM
- Low personal income tax rate capped at £100,000 per individual
- Government funding of up to 40% available towards costs of relocation, marketing, hardware and software
